#### The Agreement between Good Catch Publishing and the Church

The above named Church, hereafter referred to as the “Church,” agrees to the following, in order that Good Catch Publishing may produce a book of the Church’s stories.

The Church will submit 12 testimony surveys of potential storytellers to Good Catch Publishing via fax or mail. Good Catch Publishing will produce a book, 150 to 200 pages in length, containing seven stories. Its trimmed size will be 5 ¼ by 8 ¼ inches. GCP’s graphic artist will create the cover with the art the PIC has approved. The Church may choose from the stock art at our website at no additional charge, or the Church may commission a custom cover for a fee of \$400.00. The Church will use Good Catch Publishing’s graphic artist.

Good Catch Publishing will interview and write the stories as they were presented in the storytellers’ interviews. A fee of \$25.00 will be added for missed interviews by storytellers. Good Catch Publishing is not responsible for the accuracy of the stories. The stories will be reviewed by the storytellers for accuracy. Storytellers must sign a Release of Interest Form for their story to be used. If a storyteller refuses to sign a Release of Interest after the story has been written, the Church will be charged an additional fee of \$350.00 for the writing of the story. All additional fees will be collected upon completion of the book and before going to print.

If, after any story has been written and approved by the storyteller, the Church or the storyteller elects to change out a story, Good Catch Publishing will write and replace that story for a \$350.00 fee.

The cost to create the book will be \$1500.00 *plus a subscription of 40 books per month for 36 months.* (A total of 1440 books at \$6.25 each. ) The first subscription payment will be collected on the 20th day of the month following the date of this contract. Each remaining subscription payment will be collected on the 20<sup>th</sup> of each month prior to shipment for the duration of the contract and until all 1440 books have been purchased and paid for. If upon completion of the creation of the book, the Church decides to make a larger purchase, all subscription payments previously received will be credited toward the new agreement at the rates agreed upon in that agreement and the new agreement will supersede this agreement. The Church will accumulate a credit of 40 books per month until the book is completed. Upon completion, Good Catch Publishing will ship the credited books and then begin shipping each month’s subscription on the first of each month until the 1440 book subscription is completed. The church may accelerate shipment of their

subscription by contacting and authorizing Good Catch Publishing and making the necessary arrangements. At the conclusion of the contract, it will become an automatic month to month purchase and can be cancelled or changed at any time.

The Church must submit, along with this signed contract, the Authorization for Automatic Billing and a voided check **OR** a Credit Card Authorization Form. This signed contract and the Authorization for Automatic Billing or the Credit Card Authorization Form will constitute an agreement authorizing Good Catch Publishing to automatically collect the \$1500.00 creation fee and to begin the process creating the book and collect the minimum subscription fees for the duration of the 36 month subscription. This contract can only be superseded by another subscription contract if agreed to by Good Catch Publishing and signed by the church.

If all the storytellers approve their written stories within the three-day deadline, the pastor approves the first text copy of the book within seven days and the pastor/PIC approves the formatted version of the book within three days, Good Catch Publishing will complete the book within 75 days of receiving the surveys and will ship the initial copies within 90 days. All future financial transactions will be conducted via Automatic Billing or credit card. The book will not be printed until Good Catch Publishing receives written approval from the Church. To reduce costs, we do not accept checks.

Good Catch Publishing will own all copyrights to the book produced. Permission must be secured from Good Catch Publishing to reproduce the book in any format including but not limited to electronic or audio.
