## Agreement for Good Catch Publishing to Publish a National Testimony Book

The **Person in Charge (PIC)** will be the primary go-to person at the church. He or she will be the person the project manager will contact with issues and concerns. He or she will approve the title, cover art and give the final approval on all stories.

The above named Church, hereafter referred to as the “Church,” agrees to the following, in order that Good Catch Publishing may produce a book for the Church.

The **Launch Date** for the book will be \_\_\_\_\_. In order to secure this date, Good Catch Publishing will collect a \$200.00 non-refundable down-payment upon receipt of this agreement. \_\_\_\_\_ (Initial here)

Good Catch Publishing will produce a testimony book for the Church consisting of two stories of people in this church and five pre-written stories selected from our Good Catch Publishing story archive. The book will range in size from 165 to 225 pages. It will have a four-color UV coated cover and a “perfect” binding. The final trimmed size will be 5 ¼ by 8 ¼ inches.

The Church will provide the contact information from 10 individuals (or couples) who have given permission to be contacted to conduct interviews with writers from Good Catch Publishing. Good Catch Publishing will provide a project manager who will oversee the production of the book.

Good Catch Publishing will completely schedule, interview, write, accuracy check, edit, proofread, typeset, design a custom cover and print this book.

The writing process will begin 12 weeks prior to **Launch Date**. The Church agrees to pay Good Catch Publishing \$200.00 per month during the writing process. There will be a minimum charge of \$600.00 (the \$200.00 down payment will be applied toward this amount). If the book takes longer than 12 weeks to produce because GCP has missed deadlines, there will be no additional charge. If the production time is extended because of the Church’s tardiness, there will be an additional \$200.00 charge at the beginning of each new month until we have received permission to print the book in full from the PIC. The Church may cancel the project at any time, but no refunds will be given. If after writing a story, the storyteller opts to not have his or her story published, a \$300.00 story replacement fee will be charged the Church in addition to the \$600.00 minimum. If a storyteller misses an interview, there will be a \$25.00 “missed interview” fee to compensate our writer for his/her time. This will be charged in addition to the \$600.00 minimum.

Each week of the eight weeks prior to **Launch Date**, Good Catch Publishing will supply a video for the church to play during each Sunday morning service. The church is required to play the supplied video on

the corresponding Sunday. This is required to prepare and equip the people to use this book as an evangelistic tool. The Church agrees to play the video each week during the writing process. \_\_\_\_\_ (Initial here)

On the **Launch Date** given above, a representative of Good Catch Publishing will arrive and be given the entire Sunday morning service to launch the book, instruct the church in using the book in personal evangelism and will raise the donors to purchase books. Donor cards will be given to all the attendees and Church members, and they will be given an opportunity to make a monthly or one-time donation for the purpose of paying for the books. The cards will be collected and given to the representative of Good Catch Publishing. \_\_\_\_\_ (Initial here)

After the Church has fulfilled the requirements of this contract and the Good Catch Publishing representative has collected all the donor cards, Good Catch Publishing will ship the number of books that the donors pay for each month, as long as the donations are received by Good Catch Publishing. The donors may cancel at any time. Good Catch Publishing will only provide books to the Church that have been paid for by the donors. Good Catch Publishing will provide a report to the Church of all the donations that have cleared or failed. The Church may purchase additional books if they so desire at a price that will be agreed upon at the time of that purchase.

If the Church fails to keep its commitment to fulfill all the portions of this contract, the Church will forfeit the funds they have paid Good Catch Publishing in the process of writing the book.

Good Catch Publishing will retain all copyrights for the book published by Good Catch Publishing.
